### Camping Fees

1. Select a vacant campsite and return to register within an hour.
2. Remove a permit from the dispenser and complete form.
3. Insert payment into the envelope. Make cheques payable to 'Friends of Spruce Woods.'
4. Seal and deposit envelope in the slot below.
5. Tear off copy of envelope as receipt.
6. Please keep receipt visible on your vehicle or camping unit.

### PLEASE NOTE:

- Camping permitted in designated sites only. Sites available on a first come, first served basis. Please review and follow regulations under the Campers Guide.
- One camping unit and vehicle per site. Park extra vehicles and trailers in designated parking area.
- All camping units must have a valid camping permit.
- Additional charges will apply for failure to register.
- Check-in time is 4 p.m. Check-out time is 3 p.m.
- All manure must be picked up and put into the manure trailer or designated manure disposal site. Manure trailer is for everyone's use; please take your turn on dumping the manure trailer at the disposal site.

### Campers Guide

**Quiet time** is 11 p.m. to 9 a.m. The use of items such as radios or generators during this time is prohibited. Only permit holders returning to their designated campsites allowed into campground after 11 p.m.

**Disturbances:** Excessive noise or disturbance that intrudes on other campers is not permitted. This includes damaging property, fighting, screaming, loud music, insulting or obscene language, drunkenness or other disturbances. Failure to comply with these rules will result in enforcement actions, which may include a public disturbance charge under the Park Activities Regulations (set fine of \$673) and/or being evicted from all provincial parks for a period of up to 21 days. More serious disturbances could result in a charge for breach of peace under the Criminal Code and/or a ban from all provincial parks for one year. No refund will be issued.

**Registering for a campsite:** Upon arrival, an individual must register and acquire a valid permit to be on site. The permit can only be registered for one site and only in the registrant's name. Registering on behalf of another individual is not permitted.

**Consumption of Alcohol** is only permitted on campsites.

**Cannabis:** The smoking, vaping and consumption of non-medical cannabis is prohibited in most areas of provincial parks including campgrounds, roadways, trails and public spaces. This prohibition includes inside a tent, camper trailer or motor home located on a campsite.

The use of authorized medical cannabis is restricted to non-public spaces, and not to be used in the campground, roadways, trails or other public spaces.

**Generators** may not be used between 11 p.m. and 9 a.m. They may not be used if the permit holder or immediate family is not present on the site. Continuous generator use during the day is not allowed.

**Persons on site** cannot exceed six people or one family. The permit holder must be present on site. Guests must leave campsites by 11 p.m. The permit holder is responsible for the conduct of all persons using the site.

**Age Requirement:** A camping permit may only be issued to an individual 16 years of age or over.

**Equipment on campsite:** Only one camping unit is permitted per site. If space allows, an additional tent and/or dining tent may be set up on the campsite. A stock trailer with living quarters is only permitted if space allows. Stock trailers without living quarters should be parked away from campsites in designated parking areas. Vertical tarps are not allowed.

**Pets** must be leashed and under control at all times. Owners must clean up after their pets. Never leave your pet unattended.

**Length of stay:** No person or camping unit is allowed to occupy the same campsite for more than 21 consecutive days.

**Wildlife:** Do not feed or harass wild animals. Do not leave food, garbage or other attractants out. Report all bears to the park office.

**Campfires** in designated fire pits only and must be extinguished when the site is unoccupied. Removal of cut firewood from the park, and cutting or gathering living or dead wood is prohibited.

**Loaded Firearms** cannot be carried or discharged within 300 metres of any developed area (campgrounds, roads and designated trails).

**Fireworks** and sky lanterns are prohibited.

**Off-road vehicles:** ORVs such as ATVs and dirt bikes are prohibited in Spruce Woods Provincial Park.

**Park Vehicle Permits are required. Available at the Kiche Manitou Campground Office or online at [manitobaicensing.ca](http://manitobaicensing.ca).**
